Our **Tanalised** range of preservatives included Diffusol, Vacsol T Timber Insecticide, Tanalith Ti, Vacsol T, Vacsol Azure, Vacsol Green, Tanalith E, and Tanalith O.

Tanalised timber is easily identified by the tanalised diamond logo which appears on the brand or label identifying the hazard level of the end use application for which it is approved under Australian standards.

Q. What are TANALISED products?

TANALISED products are a range of treated wood products protected with Lonza Wood Protections formulated preservatives and offer excellent performance against decay and insect attack for building, landscaping and rural applications.

Q. When should I specify or use TANALISED products?

TANALISED products should be specified for applications where timber or wood products are required to comply to AS1604 for protection against attack from decay or insects in hazard levels H1 through H6. Refer to the Hazard Level guide on www.tanalised.com to determine which Hazard level is required for your end use application.

Q. What are the safe handling procedures?

Similar to working with untreated timber, use common sense safety and hygiene precautions. Keep your work area clean, avoid inhalation of wood dust, wear appropriate safety equipment for the tools you are using (such as safety glasses when power sawing) and wash your hands before meal breaks and after work.

Q. Can I use TANALISED products around food, water, vegetables or other plants?

As with any treated wood, Tanalised products should not be used in direct contact with human food or drinking water during storage or preparation. Incidental contact of food with treated timber, such as in play grounds, picnic tables and decks is fine as there is little or no potential for migration of the preservative onto the food. Similarly, TANALISED products are suitable for grape and tomato stakes, garden edging landscaping, mushroom trays, greenhouse uses and similar applications.

Q. What about pets and animals?

In the great majority of cases with domestic pets, farm animals, including bee hive construction and wildlife TANALISED wood is safe. Treated timber is not recommended for use with parrots or other gnawing animals nor for use in fish ponds.

Q. What Fasteners should I use?

Similar to untreated timber corrosion resistant metal fixings and fasteners are recommended in weather exposed or damp situations.

Hot dip galvanised, nickel coated or stainless steel should be suitable as well as non-ferrous alloys such as monel, brass and silicon bronze.

Contact between TANALISED products (using Tanalith O and Tanalith E) and zincalume coated sheet steel roofing may cause pitting of the metal coating.

Q. How do I maintain my TANALISED product?

As for all timber in exterior, weather exposed situations, painting or staining is strongly recommended for protecting against bleaching, surface moulds and stains, cracking and dimensional movement.

Freshly exposed surfaces from cutting or machining should be resealed with an "in can" timber preservative solution such as Tanalised Ecoseal.

To obtain the best performance with your TANALISED products, Lonza Wood Protection recommends the use of Tanacare Timbercoat.

Always follow the paint manufacturer's instructions for application and maintenance of the coating.

Q. How do I dispose of timber wastes and offcuts?

TANALISED wastes and offcuts can be disposed of through normal waste collection and disposal services. Treated sawdust and shavings are not recommended for composting, mulching or for use as animal litter.

Q. Can I burn TANALISED offcuts?

DO NOT BURN. Like all treated timber TANALISED must not be burnt in domestic heaters nor used as cooking fuel. Most states have laws against the open burning of treated timber.
